

**END-USER LICENSE AGREEMENT FOR DIGIUM SOFTPHONE**  
**June 12 2017**

**IMPORTANT – PLEASE READ CAREFULLY**

**1. Definitions**

**“Affiliate”** means an entity which is (a) directly or indirectly controlling Digium; or (b) which is directly or indirectly owned or controlled by Digium.

**“Digium”** means both Digium, Inc. and Digium’s Affiliates.

**“Original Software”** means the software, sounds (for example, ringtones), interfaces, content, fonts, documentation, and any data that are delivered with Software.

**“SIP User Agent”** means a network end-point used to create or receive SIP messages and thereby manages a SIP session.

**“Software”** means Digium manufactured and branded softphones which are SIP User Agents. Software collectively means both the Original Software and any Software Updates.

**“Software Updates”** means updates or replacements provided by Digium for the Original Software in the form of feature enhancements, software updates, bug fixes, upgrades, otherwise modified versions of the Original Software, or system restore software provided by Digium, whether in read only memory or on any other media or in any other form.

**“You”, “you” or “your”** means collectively the licensee, purchaser, and end user.

2. **EULA.** This End-User License Agreement (the "Agreement" or "EULA") is a legal agreement between Digium and You regarding the license terms of the Software. By using the Software or downloading a Software Update, as applicable, you are agreeing to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement do not use the Software and if installed, uninstall the Software. Copies of Digium’s Return Policy and Warranty Policy may both be found on [www.digium.com](http://www.digium.com) and the terms of those policies are incorporated herein by reference.
3. **GRANT OF LICENSE.** The Software is licensed, not sold, to you by Digium for use only under the terms of this Agreement. Subject to the terms and conditions of this Agreement, Digium grants you a non-exclusive, non-sublicenseable, non-transferable license to use and install one copy of the Software on a single mobile device that you own and control (the “Device”) and to maintain one backup copy of the Software, solely in machine executable object code form and solely for your personal use. . Notwithstanding the foregoing, Digium acknowledges that certain components of the Software may be covered by so-called “open source” software licenses (“Open Source Components”). Digium will provide a list of Open Source Components for the particular version of the Software you are using upon your request. To the extent required by the licenses covering Open Source Components, the terms of such licenses will apply in lieu of the terms of this Agreement, and Digium hereby represents that only Open Source Components with licenses that intend to grant permissions no less broad than the license granted in this Section 3 are included in the Software. To the extent which the licenses applicable to an Open Source Component prohibit any of the restrictions in this Agreement with respect to such Open Source Component, such restrictions will not apply. A list of the licenses under which the Open Source Components are made available is provided in Exhibit A and those terms are incorporated herein by reference.
4. **PRIVACY.** Digium respects your privacy. Please read the following statement that applies to data collected by Digium through the Software. The Software uses Google Analytics to collect a variety of information including but not limited to which features you use, behavior flow, and your city. This information is reported to Digium’s Google Analytics Account for the purpose of improving the performance of the Software. The following information is excluded from being collected pursuant to the foregoing: call logs, recording details, login and logout activity, extension details such as name, address, and password, SIP provider details such as username and password, phonebook entries for names

and phone numbers, administrative-user information, and audio files. In the event of a crash, the Software uses Xamarin Insights to perform internal analytics and assess the issue, and to report details about the crash to Digium's development team. In order to do this Xamarin Insights collects information such as device type, operating system and version, crash date, crash log, and device information (network connectivity, cellular carrier, charger, Bluetooth, etc.) In the instances of both Google Analytics and Xamarin Insights the information may be stored by Digium perpetually. Digium may share and disclose the foregoing information in aggregated form in order to describe our Software to prospective and existing partners, advertisers, or other third parties, and for other lawful purposes. The aggregated information will not be linked to any personal information that can identify an individual person or company. 5. **RESERVATION OF RIGHTS.** Except for the limited license rights expressly granted in this Agreement, Digium reserves all rights in and to the Software and any modifications thereto, including title, ownership, trademark, copyright, patent, trade secret and any other rights and interests.
6. **EMERGENCY CALLS.** DO NOT USE THE SOFTWARE TO DIAL 911. IN AN EMERGENCY, EXIT THE SOFTWARE AND DIAL 911 FROM YOUR IPHONE OR ANDROID PHONE. YOU ACKNOWLEDGE AND AGREE THAT THE SOFTWARE IS NOT A SUBSTITUTE FOR A TRADITIONAL TELEPHONE AND THAT YOU WILL NOT USE THE SOFTWARE TO CALL 911.

16. **GOVERNING LAW AND JURISDICTION AND DISPUTE RESOLUTION.** This Agreement shall be governed by and construed under the laws of the USA, and to the extent no federal law applies, the laws of the State of Alabama, USA. Forum, jurisdiction, and venue shall be determined in accordance with such law. If permitted by applicable law, Digium and you hereby expressly waive any right to a trial by jury and consent to a bench trial in the event of a dispute. Digium and you agree to attempt to resolve any dispute by direct communication between representatives of each party who are authorized to finally resolve the dispute prior to filing any legal action against the other party. The parties agree to attempt to resolve the dispute within fourteen (14) days of notice of the dispute having been provided to the party not invoking this clause and agree not to resort to legal action, other than injunctions, during the fourteen day dispute resolution period. The United Nations Convention on International Sale of Goods, the application of which is expressly excluded, does not govern this Agreement.
17. **ENTIRE AGREEMENT.** This Agreement constitutes the entire understanding between the parties relating to the subject matter hereof and supersedes all prior writings, negotiations or understandings with respect thereto. The provisions of this Agreement shall take precedence over any conflicting terms in any subsequent purchase order, documentation or collateral. The parties agree that this Agreement may be executed electronically and that electronic copies of this Agreement shall be binding upon the parties. If any provision of this EULA is held to be void, invalid, unenforceable or illegal, the other provisions shall continue in full force and effect.

- a. **ACKNOWLEDGEMENT.** You acknowledge that the Agreement is concluded between You and Digium only, and not with Apple, and Digium, not Apple, is solely responsible for the Software and the content thereof.
  - b. **SCOPE OF LICENSE.** The license granted to You for the Software is limited to a non-transferable license to use the Software on any iPhone or iPod touch that the You own or control and as permitted by the Usage Rules set forth in the App Store Terms of Service.
  - c. **MAINTENANCE AND SUPPORT.** Apple has no obligation whatsoever to furnish any maintenance and support services with respect to the Software.
